As the **APPLICANT**, I hereby certify that the information I have provided on the form is complete and accurate to the best of my knowledge. I agree to abide by the terms set forth in this application, and the Rules & Regulations of the Town of Huntington Department of Parks & Recreation. I understand that failure to do so may lead to the cancellation of the Permit, the denial of future permit applications, or other legal action by the Town of Huntington.

The **APPLICANT**, whether an individual or organization, agrees to hold harmless and defend the Town of Huntington, its officers, agents and employees, jointly, severally, individually or in their individual capacity, from and against any claim, damage, cost, fee including reasonable attorney fees incurred or arising out of the **APPLICANT'S** use and/or occupancy of the Town of Huntington's facilities.

The **APPLICANT** agrees to maintain for all dates and times covered under this application and subsequent permit, Comprehensive Liability and Property Damage Insurance in the amount of/TWO MILLION AND NO/100 DOLLARS (\$2,000,000.00) per occurrence.

The **APPLICANT** further agrees that the Town of Huntington and the Town of Huntington Board of Trustees shall be included as Certificate Holders and Additional Insureds, by endorsement on all policies. All coverage is required to be primary and non-contributory for Town of Huntington and Town of Huntington Board of Trustees, their agents, servants and employees.

As of Fall, 2018, it is required that a working AED must be at all games and practices. Head and assistant coaches for all sports teams receiving Town field permits receive training in CPR and use of AED's. Each league must supply a working, portable AED to each team for potential use at all games and practices.

The Town will offer multiple classes to the coaches, but if a coach cannot attend these classes, he or she must attend an alternate program on their own. Proof of attendance in a prior program or alternate program is sufficient to meet this requirement.

In order to play or practice a game, at least one coach or staff in attendance must have the required training or the practice or game cannot occur.

In order to hang a sponsorship sign on any town field fence or concession building, an application must be filed with the Town's office of Parks and Recreation.
